Owners of desexed dogs may apply for fee relief on existing dog registrations if the owner is 60 years of age or over, or hold a DVA Card issued by the Department of Veterans' Affairs. This will reduce the registration fee to NIL. Proof will be required with this application for those applying for fee relief.

This relief will apply to the first two desexed dogs only and all other dogs registered will be at the nominal rate for the registration class.

This does not apply to any desexed dog that has been declared as a regulated dog (dangerous/menacing).

Lodgement of this application does not constitute approval and the City of Gold Coast (City) reserves the right to refuse applications.
