The Volunteer Graffiti Removal Program is open for participation by groups who wish to supervise and manage volunteers to remove graffiti from Gold Coast city.

Groups can be registered charities, incorporated organisations or groups of two or more people with a proven capacity to manage volunteers and projects. Groups must have adequate insurance, both public liability and workers compensation, and be willing to follow set processes and procedures. Graffiti removal can be undertaken from City assets, private property, businesses and community sites. The support able to be provided by the City of Gold Coast (the City) will vary depending upon which locations are chosen, and may include pre-matched paint, training and basic equipment.

Groups wishing to participate can complete this Expression of Interest (EOI) form to nominate themselves and potential graffiti removal sites. Even if your program will only occur on private property, it is requested you complete this EOI as there may be resources available to you.

You will be contacted once the EOI has been reviewed. If your proposal is approved, a Memorandum of Understanding (MOU) between the City and your group will need to be signed. The MOU clearly defines the roles and responsibilities of each party.
