1. A refundable deposit of \$89.40 per bin applies (compulsory for hire of all bins).
2. Replacement cost for damaged or stolen bins are:
  - 240 litre \$81.30
  - Bulk bins – actual cost, depending on the size of the bin and extent of damage.
3. Pre-payment of all temporary waste services is required.
4. Request a secure online payment via BPAY or credit card – a credit card surcharge applies.
5. Payment can be made at any City of Gold Coast Customer Service Office or by mail (with accompanying cheque made payable to the City of Gold Coast).
6. A minimum of 48 hours' notice is required for processing (longer is required if mailing).
7. Any alterations or cancellations require at least 24 hours' notice (business days); otherwise full services charges will apply.
8. Wheelie bins must be presented kerbside by 6am on the required service days and for removal.
9. If bulk bins are moved from the delivery location, they must be returned prior to service and removal.
10. Access to bins for servicing and removal must be maintained.
11. Please ensure waste is adequately contained in the bins at all times and that bin lids are closed.
