## **Part 1                      Preliminary**

### **1                      Short title**

This subordinate local law may be cited as *Repealing Subordinate Local Law No. 1 (Miscellaneous Subordinate Local Laws) 2008*.

### **2                      Authorising local law**

This subordinate local law is made pursuant to—

- (a)        *Local Law No 1 (Meetings)*; and
- (b)        *Local Law No. 4 (Libraries)*; and
- (c)        *Local Law No 5 (Distribution of Business Advertising Publications and Touting)*; and
- (d)        *Local Law No. 7 (Control of Advertising Devices)*; and
- (e)        *Local Law No. 8 (Rental Accommodation) 1999*; and
- (f)        *Local Law No. 9 (Parks and Reserves)*; and
- (g)        *Local Law No. 10 (Water Carriers)*; and
- (h)        *Local Law No. 11 (Roads and Malls)*; and
- (i)        *Local Law No.13 (Hinze and Little Nerang Dams)*; and
- (j)        *Local Law No. 42 (On-site Sewerage Facility) 2002*.

### **3                      Object**

The object of this subordinate local law is to repeal the following subordinate local laws—

- (a)        *Local Law Policy No 1 (Meetings)*; and
- (b)        *Local Law Policy No. 4 (Libraries)*; and
- (c)        *Local Law Policy No 5 (Distribution of Business Advertising Publications and Touting)*; and
- (d)        *Local Law Policy No 7 (Control of Advertising Devices)*; and
- (e)        *Subordinate Local Law No. 8 (Rental Accommodation)*; and
- (f)        *Local Law Policy No 9.1 (Parks and Reserves)*; and

- (g) *Local Law Policy No.10 (Water Carriers); and*
- (h) *Local Law Policy No. 11 (Roads and Malls); and*
- (i) *Local Law Policy No 13 (Hinze and Little Nerang Dams); and*
- (j) *Subordinate Local Law No. 42.1 (On-site Sewerage Facility) 2003.*
